1. SGM update (Dillon)

Several issues were raised before CF. Local and regional authorities delegation of responsibilities about the Alcohol Policy. May need a generic alcohol policy nationwide, and a regional policy. Dillon will talk to more people about this and follow up the regional council around CF. Check if there are differences for members or public.

3. Background and purpose of SCANZ Child Policy and nominated caregiver. (raised at SGM)

Committee is comfortable with the policy. Angela will send through the nominated caregiver form. Will discuss further on the list.

4. Food Act (raised at SGM)

Committee to push to March.

5. Policy Publicity (Dillon)

We have a website with the policies on them. Standing item on Agenda, are their policies that we need to promote or remind members of them. Either all lists to members and non-members, or just members.
