

# SCANZ Committee Minutes - June 2025

Meeting opened 7:30 pm 16 June 2025.

## Agenda

- 1) Conflict of interest - none advised.
- 2) Previous minutes (Item 1) - accepted without change.
  - a) Action points (Item 2)
- 3) Correspondence:
  - a) SCA Ltd
    - i) Greeting noted from new Board members. We are not receiving advice or invites to SCALA meetings. **Action** by Scott: get these coming to the SCANZ committee list. We don't want to see routine SCALA committee list activity, just the meeting notices.
  - b) Kingdom Seneschal -
    - i) query re NZ group boundaries - no further action
    - ii) draft Email for DEIB Officer appointment received. Discussion:
      - (1) this is a corporate officer appointment. Job description can't reference Kingdom requirements. SCALA and SCANZ will have slightly different requirements.
      - (2) SCALA has to take over Australian DEIB appointment. Likewise SCANZ for NZ appointment. Akin to the Webmaster role, DEIB could be done by a committee member if we don't have a separate officer.
  - c) Insurance -
    - i) invoice received, payment in progress.
    - ii) clarification received: event membership is a valid thing to extend public liability insurance.
    - iii) status of children re insurance is not clear. **Action** by Kerry - put the child question to Marsh.
    - iv) marshals - are there possible insurance issues from event MIC appointments not being tracked by SCANZ? Do we understand the actual insurance hazard?
    - v) need to pass on advice re Yule event to Marsh (insurance broker). **Action** by Scott.
  - d) Companies Office
    - i) Intent to re-incorporate SCANZ was gazetted 5 June, then 20 working day wait, hence expect action about 5 July.
  - e) Garden City Accounting
    - i) (re-)incorporation thing seems to have upset their records. Action by Richard - advise of re-incorporation in progress.
    - ii) Anti-Money Laundering legislation requires photo ID for committee and executive people. **Action** for everyone - provide certified copies to Richard to forward.

  - c) Moving all money from old accounts is glacial, but proceeding.
  - d) Update of progress to account signatory changes:

- i) **Action** by Kerry - corner Westpac rep to see what is happening.
  - e) Consequential actions from the increase in fees:
    - i) update to PDF membership form (rates, privacy info). **Done**. Needs to be posted on the SCANZ site. Regnum new member page to have privacy text updated also. **Action** by Scott to arrange this.
    - ii) update SCANZ postal address in the Societies database to Zara's postal address. **Action** by Richard, as part of re-incorporation.
  - f) Unified event booking system - no action.
  - g) NZ exchequer role - no action.
  - h) New account for Sherwater is pending admin right changes in d) (shiring expected 27 July 2025).
- 5) Registrar's Report
- a) Nothing received.
- 6) Kingdom Seneschal's Report
- a) Received by email. Things are ticking over, no significant issues.
- 7) Progress reports from working groups
- a) Alternative Crown report
    - i) Poll results: 58.5% (1150) of the collective members voted in the poll, and 79.6% of votes were in favour of conducting trials. Seems the trial notion is popular. SCALA and SCANZ need to get together for next step.
    - ii) Joint meeting with Ombudsman (SCA Inc + SCALA + SCANZ). **Action**: Kerry to set up a time for a live call. No Ombudsman response to date. Keep trying.
  - b) Server migration
    - i) David R is progressively cloning content across to VPS from Paradise. Drop dead date to complete is mid-July.
    - ii) Monthly invoicing is happening. Manual payment for the moment. Should be a fixed amount per month. Scott is managing this.
- 8) Additional working groups/sub-committees
- a) Constitution -
    - i) Next steps to prep constitution for AGM (add the missing parts to make compliant with the new Act).
    - ii) SCANZ needs to clarify which officer appointments require approval, re new Inc Soc Act requirements. Part of Constitution work.
    - iii) New member class added in wiki: Junior (or similar name; under 18 yo). Not determined what benefits this class should enjoy; voting rights seems overdoing it, open to abuse. More consideration is needed.
    - iv) Add DEIB content.
  - b) Constitution & affiliation agreements - no progress. SCANZ needs to resolve remaining Constitution aspects (as in 8a) above) before any useful affiliation update can happen.
  - c) Working with Children & Youth - Jacqui to send working draft to committee list for review.
  - d) Other policies (Item 3) -
    - i) update on review of draft Information Management Policy. Implications of this policy for committee use of FB chat for discussion.
