

# SCANZ Committee Minutes

Meeting opened 7:32 pm 30 November 2025.

Attending: Kerry McSaveney (Chair), Jacqui Macgregor-Pahl (Vice-chair), Scott Campbell (Secretary), Zara Kinsett (Registrar), Tegan Hunter (Kingdom Seneschal).

Observing: none.

Apologies: Richard Goodwin (Treasurer).

- 1) Conflict of interest check. None reported.
- 2) Previous minutes (Item 1) - accepted, subject to the month at the top being corrected to "October".
- 3) Correspondence:
  - a) Kingdom Seneschal - re Strathcrobie changing from shire to hamlet. Secretary replied with SCANZ approval for the change.
  - b) Companies Office/IRD - nothing received. See section 8a.
- 4) Treasurer's Report & business
  - a) P&L - \$1140 surplus this month for Corporate and Kingdom.
  - b) Westpac Merchant Facility - making progress. Jacqui should have an application form in her email. Once completed, we can get that up and running. The establishment fee is quoted at \$45 but may be waived since we are a customer already. Also, have confirmed we can cancel as needed, so we'll just have it running for January and then stop it.
- 5) Registrar's Report
  - a) Membership at 261. No obvious trends over recent time.
- 6) Kingdom Seneschal's Report
  - a) DEIB role - needs to be with SCANZ and SCA Ltd corporates, not a kingdom role. SCANZ DEIB role is currently retained by the committee, pending our call for applications (needs a job description).
- 7) Progress reports from working groups
  - a) Alternative Crown
    - i) Joint meeting with Ombudsman (SCA Inc + SCA Ltd + SCANZ). **ACTION:** Kerry to set up a time for a live call. Ongoing issues of finding a common time (or even getting a reply from SCA Inc). Noted that SCA Inc board has completely turned over since AltCrown project was started.
    - ii) Report from Ray/Gomez - not circulated to all SCANZ committee. **ACTION:** Kerry to circulate material to other SCANZ committee members for review.
  - b) Server migration - all web assets are now on the VPS. Mail lists are upgraded to Mailman3 on Paradise; stability checks before transferring to VPS. Started discussion with Masonry about ongoing support of VPS.
- 8) Additional working groups/sub-committees
  - a) Constitution & affiliation agreements
    - i) IRD will not accept current Constitution wording, despite it being compliant with the IncSoc Act. Need an SGM to touch the Constitution to knuckle under to IRD wording

demands. **ACTION:** Scott to a) arrange this meeting for CF; b) send out notice of meeting in time.

- ii) constitution changes have effects on Kingdom Law. **ACTION:** Kerry to circulate draft changes to Kingdom Seneschal and committee for review/comment.
- iii) review effects of constitution changes on affiliation agreement. No action this month.
- b) Working with Children & Youth - no action this month.
- c) Other policies (Item 3) -
  - i) update on review of draft Information Management Policy. No action this month.

#### 9) Other business

- a) Insurance - Seneschal's event database sent two notifications: Canterbury Fair 2026 and St Sebastians 2026, with expected revenue exceeding \$10k. **ACTION:** Scott to pass these on to our broker.
- b) Committee Trello board content, review (Scott) - no action this month.
- c) Warrants for other SCANZ officers, update. No action this month.
- d) SCANZ officer declarations are coming in, slowly. Some B&B and group seneschals yet to return their declarations.  
**ACTION:** Scott - a) chase up the missing declarations; b) file the received declarations in the SCANZ Google Drive, sorted by date to make age-out management easier.
- e) Groups page update for Sherwater - webwright sent query to respective seneschals asking their view on boundaries. No reply yet.
- f) Committee absences and coverage: nothing advised.
- g) Disputes (public excluded).
- h) Next meeting to be on 18 January, adjacent to the Special General Meeting. Current Constitution allows to skip a December meeting.

a) Youth Armoured Combat rules received (see Business).

b) Insurance – Kerry responded to provide the forms and information they requested. Given the high cost to include coverage for equestrian activities, we appear to be better off to specifically cover individual events that will include equestrian.

c) Email of concern received regarding an advertised SCA feast where homekill would be served. Kerry contacted the organisers and this feast did not run.

d) IRD – No response to Kerry's emails.

b) Sherwater – Bank account all sorted. Waiting for signatories to complete their paperwork.

c) Webhosting AP corrected – had been set as fortnightly, now paying monthly as intended.

d) Merchanting – estimated at \$85 for establishment, then minimum of \$20/month. Need to work out short term costs or re-establishment fee.

MOTION: To grant the Treasurer authority to set up Westpac Merchant Facility providing the costs are reasonable. PASSED.

Amendment requested by SCANZ – remove references to "Terra Rosa" and "Crescent Isles".

MOTION: Approve the YAC Handbook subject to minor amendments. PASSED

b) Officer Consent Forms – more have been received. Kerry has a spreadsheet of those required and whether or not we have received them.

ACTION: Kerry to follow up on those still outstanding.
