
- 1) Conflict of interest check none advised.
- 2) Previous minutes (August) accepted. Noted late correction received from Trent for July minutes re name of Cluain seneschal. **Action**: Scott to update published July minutes with annotation. a) Action points (Item 2) cover in business.
- 3) Correspondence:
- a) SCA Ltd ACWG meeting 24 August with SCA Ltd, SCANZ, Gomez, minutes. See detail in 7 below.
 - b) SCA Inc nothing (!)
 - c) Insurance broker discussion with Kerry. To clarify exclusions in our current public liability policy, e.g., equestrian not covered (used to be), hot work not covered (not specified in the past), temporary members not covered (?). **Action:** Kerry to keep on at this.

- b) Issue with Westpac not properly processing beneficial owner change is resolved. Business Online access is enabled for those new people that need it.
- c) Set up Ildhafn reeve (Nicola) in Xero. Processed expense claim from Scott and Day of Dance transfer.
 - d) Paperwork for new Sherwater account is delivered.
 - e) Considering options for digital event sign-in at Gate. Thorbjorn has sketched up a possible Cognito implementation. Discussion: current Cognito account has little/no separation between users; upgrade to new features has notable annual cost (\$US336 pa). Discussion re valid signature (check box vs touch screen squiggle), but no resolution. Agreed that Richard develop this proposal further with Thorbjorn.
 - 5) Registrar's Report
 - a) By email. Membership substantially flat.
 - b) Charge for a replacement membership card is not well defined. Given that postage is \$3 plus cost of laminating materials, agreed that \$5 is a valid fee for this. **Action**: Scott to locate and update the necessary places.



6) Kingdom Seneschal's Report

- a) Sherwater is now with the Crown to announce at next suitable event. When?
- b) Youth Armoured Combat Rules now approved by the Crown, now to be approved by Oz BoD and SCANZ. **Action:** Tegan will forward correspondence.
- c) Question about Marshal's database: where does this sit relative to NZ Privacy requirements? TBD.
 - d) Question about KS's new "deputies", Australian and NZ, and their roles. KS clarified that they were general assistants, with no delegated authority.

7)Progress reports from working groups

- a) Alternative Crown report i)Joint live meeting of SCA Inc + SCA Ltd + SCANZ to be set up. No response from Ombudsman. Kerry will start copying in SCA Inc President to attempts to make contact.
- ii)Joint meeting with Oz BoD (Catherine, Nicole), SCANZ (Scott) and Ray/Gomez 24August. In early summary: rapier tournament is easy, Championship tournament canbe made to work, Multiple Events tournament(s) does not look practical. Ray has engaged the Lochac College of Heralds to advise on necessary changes to rituals, expecting replies by 1 October. Ray expects to deliver formal report to Oz Bod andSCANZ about mid-October. Earliest date for any format changes to Crown Tournament would be Spring 2026 (stretch) or Autumn 2027 (more practical).
- b) Server migration -i) transfer of current mail services from Paradise server to VPS looks difficult. Is it timeto consider alternative ways of providing these services? Perhaps engage Masonry experts to advise.
- ii)Need to release VPS management from David Robb. **Action:** Scott to contact Masonry to explore support options.

- b)Scott proposed additional warrants in Regnum for SCANZ webwright and SCANZ DEIBofficer. Allows these offices to be searched and current holders identified. Agreed. **Action**:Scott to arrange.
- c)Pegasus do we want notice of SCANZ meetings in there? Need to provide before 26th ofprevious month. Agreed that post-meeting advice of minutes, with planned next meetingdate should be forwarded to Pegasus. **Action**: Secretary to do this routinely; add to monthlychecklist.
- d)Member absences: Scott will be away for October. Available for asynchronous email, but not live meetings.
- e) NZ group boundaries boundary between Sherwater and Darton (and Crown Lands) doesnot lie on any convenient telephone area code boundary (this works for other groupboundaries). Agreed to need some geographic definition, to allow update of the groupspage on the SCANZ website. No decision reached on the definition.
- f) Due diligence process for SCANZ committee when reviewing Crown Tournament contenders: will usually be on a short time frame; what ready reference sources do wehave? Does KS keep a record of past sanctions? Are the committee email archives good enough to discover these readily? No decision reached.
