Minutes for last meeting: Vote for accepting minutes was in a revised agenda, which it eventuates, was not sent out, so not on published agenda. Voting on minutes is usual but to required, therefore not voting on past minutes.

Chair called for objections: none.

Motion 1:

That the Accounts for the past year of the SCA NZ, Inc, be accepted.

Chair read the accounts. See appendix A for accounts in full.

AR asks that a note be put on the balance sheet to note subscription liability for next years accounts. No objections.

Revision of rules

(NB as these motions relate to changes to our rules, then as per our rules they require a 2/3rds majority to pass).

Motion 2:

That the following paragraph be removed with the understanding that voting on Motion 3 (below) shall also occur.

Paragraph 3 of section 5.1 Structure of the Committee, currently reads: Committee members may not serve as greater officers for any branch of Barony or greater level whilst serving on the Committee.

For reference, the "greater officers" are currently taken to be Seneschal, Herald, Marshal, Arts and Sciences, Reeve, Chronicler, and Chirurgeon.

Motion 3:

That if Motion 2 (above) is accepted, the following restrictions are to be placed on committee members, as determined by whichever motions are carried, and that paragraph 3, section 5.1 shall be re-written and inserted to restrict committee membership as determined by the membership.

Committee members may not be:

1-1 Seneschal of any size group.

Yes = 18 (69%), No = 8, Abstain = 1 **Motion Passed**

1-2 If the above fails, Seneschal of any group of size barony or above. Not required to be voted on.

1-3 If the above fails, Seneschal of any principality. Not required to be voted on.

1-4 If the above fails, Seneschal of any kingdom. Not required to be voted on.

2-1 Reeve of any size group. Yes = 15 (57%), No = 11, Abstain = 1

2-2 If the above fails, Reeve of any group of size barony or above.

Yes = 21 (80%), No = 5, Abstain = 1

Motion Passed

2-3 If the above fails, Reeve of any group of size principality or above. Not required to be voted on.

2-4 If the above fails, Reeve of any kingdom.

Not required to be voted on.

3-1 Any other officer of any size group. Yes = 3(12%), No = 22, Abstain = 1

3-2 If the above fails, any other officer of any group of size barony or above.

Yes = 5 (19%), No = 21, Abstain = 1

3-3 If the above fails, any other officer of any group of size principality or above.

Yes = 14 (54%), No = 12, Abstain = 1

3-4 If the above fails, any other officer of any kingdom.

Yes = 18 (**72**%), No = 7, Abstain = 1 **Motion Passed**

4-Baron or Baroness of any barony.

Yes = 19 (73%), No = 7, Abstain = 1

Motion Passed

5-Prince or Princess of any principality.

Yes = 23 (88%), No = 3, Abstain = 1

Motion Passed

6-King or Queen of any kingdom.

Yes = 23 (88%), No = 3, Abstain = 1

Motion 4:

That a new paragraph be added to the end of section 4.2.1 Payment of Membership Fees, as follows:

The committee may set different rates within each class of membership using clearly defined criteria, as determined by the committee.

Chair explains meaning of the Motion: Allows tweaking of memberships . David Robb: proposes a note to the motion that appropriate consultation need to be done before changes are implemented and ensured they are widely advertised.

Motion 5:

That a new paragraph be added to the end of section 3 Affiliated bodies, as follows

The committee may enter into affiliation agreements with SCA colleges under the auspices of a New Zealand student union, under such mutually agreeable criteria as determined by the committee.

Yes = 27 (100%), No = 0, Abstain = 0 **Motion Passed**

Motion 6:

That the second sentence of section 9.1 Annual General Meetings be reworded as follows:

The AGM shall be held within the period 4 weeks either side of the 15th November and hosted by alternating Geographical Branches as determined by the committee.

That the second sentence of section 9.1 Annual General Meetings currently reads:

The AGM shall be held during the month of November and hosted by alternating Geographical Branches as determined by the committee.
